Member Secretary welcomed the Chairman and all Members to the Governing Council meeting and introduced the newly appointed student members of UG and PG.

The Chairman asked the Member Secretary, Principal NMAMIT, to present an overview of the future plans of the Institute. In response to it, the Member Secretary provided an overview of NUCAT entrance examination held for 2022-23 admissions under Nitte Deemed to be University and the student admission details. He said that the Nitte University marketing team supported by college faculty is getting ready for NUCAT 2023. He also informed that plan for a new academic block in the existing Girls Hostel location near the college is getting ready And by 2025, the new academic block shall be ready, and the Girls Hostel will be shifted to another new building. Member Secretary explained that PCM Marks of NUCAT 2022 students are slightly better. The provision of 40% of scholarship has been given to 20% students of every branch. NUCAT 2023 entrance exams will be conducted through Online mode similar to that of NUCAT 2022. NET has been sponsoring full fees for a few economically poor and academically good students. Member Secretary talked about the Performance Based Appraisal System of the Institution. Faculty Development Programmes are conducted to train the faculty of non-IT related branches to teach computer related subjects, he said.

Chairman announced that from next year about 60% of the students in the Institution are going to be IT branch students.

Principal presented the details of the latest achievement (after the last GC meeting held on 29 January 2022) of the Institution. In the presentation he explained the publication details of the year 2018-2022.

Dr. Bhamy Shenoy, Dr.S.Y.Kulkarni and Dr. H.C.Nagaraj provided constructive suggestions concerning sustainability issues, student scholarships and Institute perception etc.

- **Applying for continuation of academic autonomy to VTU and UGC:** Institution has applied to UGC through VTU on 19 May 2022. However, the Institution management approached personally the UGC Office at Delhi and requested them to expedite the matter since there was no further communication from UGC. As per the oral instructions Institution has sent NAAC and NBA certificate copies and score sheets of NMAMIT and Nitte Deemed to be University on 10 October 2022. **Member Secretary told that with approval of Governing Council the semester end exams for the academic year 2022-23 will be conducted even if the UGC Inspection committee visit does not happen within next 2 months.**
