Member Secretary welcomed the Chairperson and all Members for the Governing Council meeting.

The Chairman in his opening remarks asked about the admission details for the academic year 2023-24. He told that in the department like E&E, Mechanical Engg. and Civil Engg. the admissions are less compared to other departments. He opined that the faculty must compulsorily be involved in research activities like presentation of good papers, publishing papers in Q1/Q2 journals etc.. He told that those who have registered for Ph.D must complete their Ph.D within 5-6 years. GC Members suggested that faculty should write books or manuscripts related to the subject syllabus and these should be kept in library for students to read.

The Member Secretary explained that the construction work of new academic block with 1.80 Lakhs sq. ft area and the hostel block of 28510 sq. ft. area are under progress. Hostel block will be ready by August 2024 and the 10 floor academic block latest by June 2026.

Dr.S.Y.Kulkarni said that Teaching is to be given utmost importance by every faculty. Dr. H.C. Nagaraj, said that the UG students also should involve in Research activities of the faculty.

Dr.M.S.Moodithaya, Member of GC told that teaching and research should go hand in hand. Sri. Vishal Hegde emphasized the need of improving research outcomes in view of NIRF requirements. The Chairman suggested to appoint a few retired faculty from IITs and NITs to improve the quality of education at the Institution. Member Secretary told that, 27 new faculty were appointed for IT related branches this year.

Member Secretary said that syllabus of UG programmes are modified and the industry specific subjects are added in the syllabus. He presented the details of the latest achievements (after the last GC meeting held on 19-10-2022) of the Institution.

In the presentation he provided the details of new B.Tech programmes and admission details. He informed that the applications for NBA accreditation for MBA and MCA programmes are already submitted. Application for increase in intake of B.Tech ISE from 180 to 240 shall be submitted during this year's AICTE approval process. Civil Engineering intake will be reduced to 60, he said.

Dr. S.Y.Kulkarni asked whether NBA accreditation is necessary for MBA programme under Nitte University. Dr. M.S.Moodithaya said that it is necessary as the MBA programme is approved by AICTE under NMAMIT. However, under Nitte University, JKSHIM is given the status of a separate Institute.

Dr.Bhamy Shenoy, Member of GC asked about the

- 1. Quantum of Research funds obtained
- 2. Alumni contributions towards infrastructure development in the college
- 3. Involvement of students in social activities

Member Secretary said that the seed grant from Nitte University has been provided for Research. About Rs.65 lakhs is approved from extramural research funds.

During forthcoming alumni meets the point about the alumni contribution may be raised, he said.

Principal mentioned that through internship, students involve in societal activities. President said that we expect Alumni to help the college through their involvement in student training, placement and project mentoring.
